Website Privacy Policy

This website is operated by or on behalf of Funtastic Limited ABN 94 063 886 199 or its related bodies corporate (**Funtastic**). Funtastic respects the privacy of your personal information of visitors to this website and is bound by the National Privacy Principles under the Privacy Act 1988 and other laws which protect your privacy.

When referring to “personal information”, we mean information which identifies you as an individual or from which your identity can be reasonably ascertained. Your name, address and phone number are examples of personal information.

This Website Privacy policy explains how personal information will be treated as you access and interact with the Website. We will post any changes to this policy on the website, so please check this policy from time to time.

In addition to the Website Privacy policy, there may also be specific and additional privacy provisions that apply to certain sections of the website – you should read and consider these wherever they appear. Information collected

The default settings of browsers like Internet Explorer always allow cookies, but users can easily erase cookies from their hard-drive, block all cookies, or receive a warning before a cookie is stored. Please note that some parts of the Website may not function fully for users that disallow cookies.

While we take great care to protect your personal information on our Website, unfortunately no data transmission over the Internet can be guaranteed to be 100% secure. Accordingly, we cannot ensure or warrant the security of any information you send to us or receive from us online. This is particularly true for information you send to us via email. We have no way of

protecting that information until it reaches us. Once we receive your transmission, we make our best effort to ensure its security in our possession.
